STUDENT'S RIGHT TO CANCEL

Student's Right to Cancel The student shall have the right to cancel the agreement and receive a full refund before the first lesson and materials are received. The refund policy for students who have completed 60 percent or less of the period of attendance shall be a pro rata refund. The institution shall pay or credit refunds within 45 days of a student's cancellation or withdrawal.
